## **CNA calls on Government to Redesign Long Term Care**

Canadian Nurses Association (CNA) calls for decisive action to respond to the staggering effects COVID-19 has had on our health-care system, economy and lives in their report **2020 Vision Improving Long-Term Care for People in Canada**. "While a Canada-wide public health campaign to flatten the curve has largely spared our hospitals the devastation witnessed in countries like Italy and the United States, the pandemic has exposed long-standing vulnerabilities in Canada's long-term care (LTC) sector," said CNA president Claire Betker. Canada has had unacceptable rates of COVID-19-related deaths in LTC; by late April, 79% of the country's deaths due to COVID-19 were linked to outbreaks in these care facilities. "These tragic numbers are in part a result of decades of neglect of the LTC sector and a growing mismatch between the level of care required by people living in those settings," said Betker.

L'Association des infirmières et infirmiers du Canada (AIIC) demande une intervention décisive pour réagir aux effets bouleversants de la COVID-19 sur notre système de santé, notre économie et nos vies dans leur rapport **Vision de 2020 : améliorer les soins de longue durée pour les personnes au Canada**. « Même si une campagne de santé publique à l'échelle du Canada afin d'aplanir la courbe a grandement épargné nos hôpitaux de la dévastation dont nous avons été témoins dans d'autres pays, comme l'Italie et les États-Unis, la pandémie a mis au jour des vulnérabilités de longue date dans le secteur des soins de longue durée (SLD) au Canada », a déclaré la présidente de l'AIIC, Claire Betker. Le Canada a enregistré des taux inacceptables de décès liés à la COVID-19 dans les maisons de SLD; avant la fin d'avril, 79 % des décès en raison de la COVID-19 au pays étaient liés aux éclosions dans ces établissements de soins. « Ce nombre tragique de décès s'explique en partie par la négligence du secteur des SLD durant des décennies et une disparité croissante entre le niveau de soins nécessaires pour les personnes vivant dans ces établissements », selon Betker.
